These trainings also provided an opportunity for 2,119 men to re-experience this training as volunteer staff. Approximately 7,000 men participated in "integration groups" which are weekly or bi-weekly circles to assist men living the principles they have learned during the initial training. Some of these groups have been in existence for over 20 years. There is no fee for participation in these groups. Five hundred and ninety one men participated in leader training events. These are to provide advanced training for individuals men on how they can achieve their leadership goals.

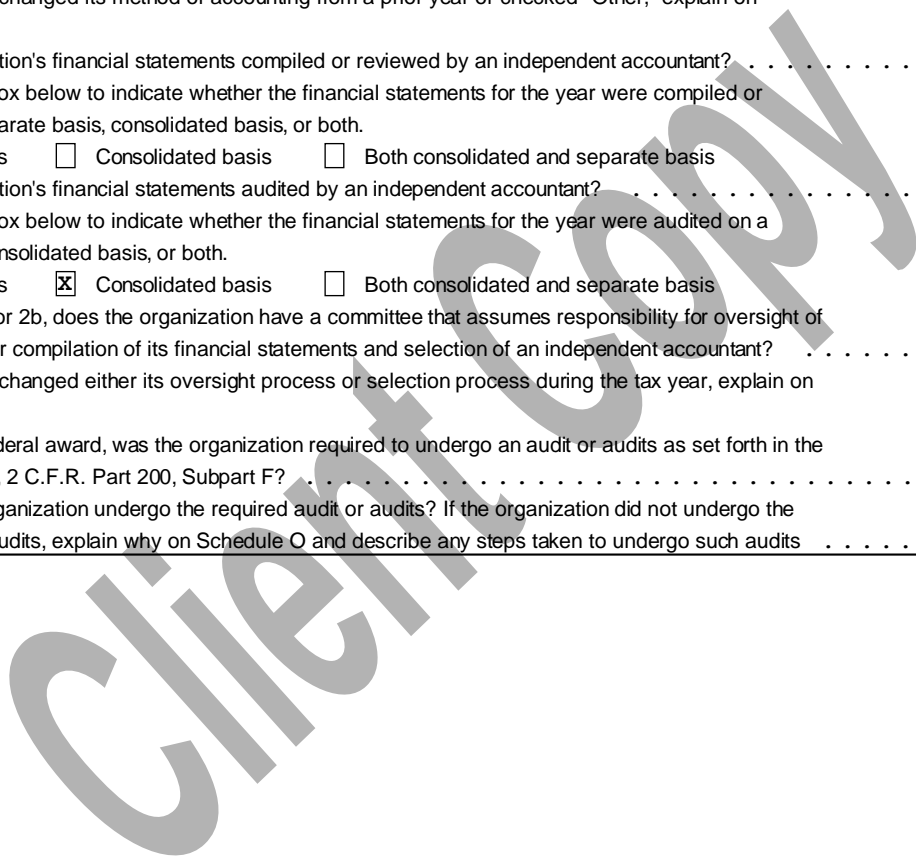
